According to Recommendation 2003/361 of the EC Commission small and medium-sized enterprises are defined as enterprises whose staff levels and economic weighting do not exceed certain limits.

- A micro enterprise employs fewer than ten people and the annual turnover or balance sheet does not exceed €2mn.
- A small or medium-sized enterprise (SME) employs fewer than 250 people and either has an annual turnover of no more than €50mn or its annual balance sheet total is no more than €43mn.
- A large enterprise employs at least 250 people or exceeds the annual sales and annual balance sheet total figures of an SME.
